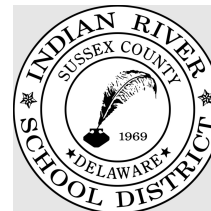
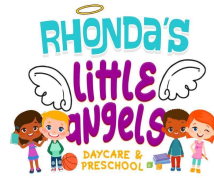

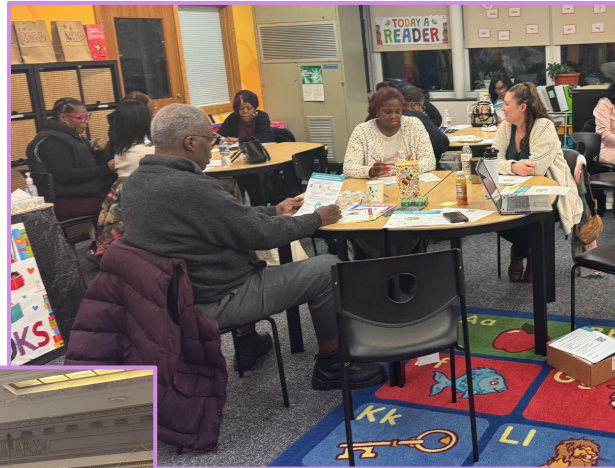

Federal Landscape

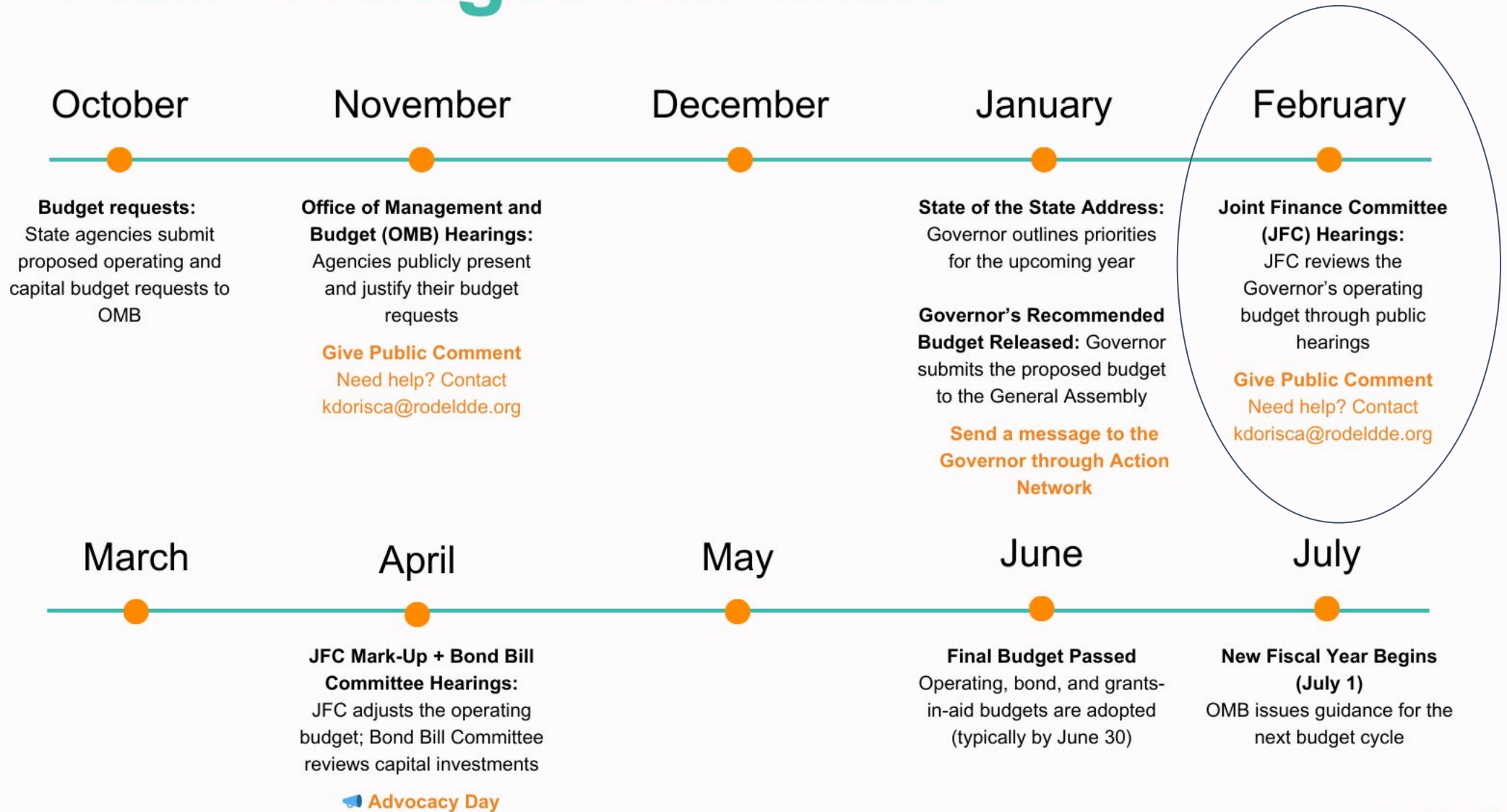
- **Federal Attacks on child care**, including recent investigations of fraud in Minnesota and threats to freeze funds
 - **In Delaware**, no evidence of fraud, and many procedures in place to prevent and address
 - **Nationally**, courts stepping in to block broad freezes and reinforce due process and federal guidance
 - **Concerns about unintended impacts** for families and providers, including fear or reduced participation
- **Threats** to Medicaid, TANF, SNAP, and public health
- **Immigration enforcement harming young children**
- ***Proposed reduced federal requirements*** for paying based on enrollment and prospectively, limiting family co-payments
 - **Delaware proceeding with these policies – funding included in Governor Meyer's Budget**

Why this matters: Together, these actions create uncertainty for states and providers, highlighting the need for **coordinated, child-centered policy responses**.

Legislation

Bills We Are Monitoring

Bill or Topic	Purpose
<u>HS1-HB 204 (Romer)</u>	Creates a dedicated team within the state's child care licensing office to handle complaints about licensed child care providers.
<u>HB 274 (Ross Levin)</u>	Increases Delaware's child and dependent care tax credit from 50% to 100% of the federal credit for all eligible taxpayers.
<u>HB 284 (Yearick)</u>	Doubles the child and dependent care tax credit for residents earning under \$60,000 and makes it refundable; the credit is unchanged for those earning \$60,000 or more.
<u>HB 259 (Williams)</u>	Requires lead screening for children ages 12 months and older before enrollment or continued attendance in child care facilities and schools.

Delawareans United in Need for Child Care Supports

Families, child care providers, and local employers continue to struggle to make ends meet, despite some positive gains in recent years.

Let's help Gov. Matt Meyer and his administration follow through on their commitment to provide universal access to pre-K throughout the state. This year let's **capitalize on Delaware's historic investments and serve even more children and families** by investing more state dollars and allowing more families to access care by increasing eligibility.

Today, **Less than 1 in 5 children are served in public programs.**

- Care is too expensive for many families, costing as much as a mortgage payment
- Employers face daily disruptions, a shrinking workforce, and business losses
- Child care providers want to offer more openings to families but cannot

We are grateful for the historic investments outlined in the **Governor's Recommended Budget for FY27: Nearly \$50 million total (\$33 million in ongoing state funding). But we must do more to reach our goals.**

Joint Finance Committee: Invest Today


Department of Education: Increase access to state-funded pre-K (ECAP)



1. Increase eligibility to serve families up to at least 300% of the Federal Poverty Level
2. Provide infrastructure funds to expand early care and education capacity through grants and by allowing public school capital funding to cover pre-K

Department of Health and Social Services: Increase access to child care (Purchase of Care) for more families

1. Increase per-child Purchase of Care rates to at least the federal benchmark of the 75th percentile so programs can open more classrooms and increase staff pay and benefits
2. Expand eligibility to serve families up to at least 300% of the Federal Poverty Level (making about 5,000 more families eligible)

Help More Delaware Families Access Early Care and Education!

Families and child care providers in Delaware continue to struggle to make ends meet, despite some positive gains in recent years.

Let's help Gov. Matt Meyer and his administration follow through on their commitment to provide access to universal pre-K throughout the state. This year let's capitalize on Delaware's historic investments and serve even more children and families by investing more state dollars and allowing more families to access care by increasing eligibility.

Some **progress has been made** in recent years, and some promising things are on the horizon. Advocates have also **identified detailed policy goals** related to early care.

But there are still significant child care needs today in Delaware. **Less than 1 in 5 children are served in public programs:** We are a long way from universal.

- **Care is too expensive for many families, costing as much as a mortgage payment** and college tuition. Only families earning below \$65,000 yearly (below 200% of the Federal Poverty Level) can access state-sponsored programs.
- **Child care providers want to offer more openings to families but cannot** due to low rates of state reimbursement and staffing shortages.
- **Employers face daily disruptions, a shrinking workforce, and business losses** due to child care challenges, with three in four (75 percent) saying such problems are hurting their business.

What is JFC & Who's There

JFC = Joint Finance Committee

- Legislative committee that **reviews and finalizes the state operating budget**
- Co-chaired by **House and Senate leadership**
- Holds public hearings on **agency budget requests** after the Governor releases the Recommended Budget

At the Hearing

- **JFC legislators** – question agencies and weigh funding decisions
- **Agency leaders** – present and defend their budget requests
- **Public commenters** – provide input and advocate for priorities
- **OMB & Governor's Office staff** – observe and support agency testimony

Goal: Influence legislative budget decisions and shape what funding is approved, increased, or cut before the final budget is passed by the General Assembly.
